# **Linnel 2 Fair Processing Notice**

This notice explains what information we collect, when we collect it and how we use this. During the course of our activities, we will process personal data (which may be held on paper, electronically, or otherwise) about you and we recognise the need to treat it in an appropriate and lawful manner. The purpose of this notice is to make you aware of how we will handle your information.

#### Who we are

Andrew & Helen Kaymer, t/a Linnel 2 Property Services take the issue of security and data protection very seriously and strictly adhere to guidelines published in the General Data Protection Regulation (EU) 2016/679 which is applicable from the 25th May 2018, together with any domestic laws subsequently enacted.

We are notified as a Data Controller with the Office of the Information Commissioner under registration number **ZA356705** and we are the data controller of any personal data that you provide to us.

## How we collect information from you and what information we collect

We collect information about you in person, over the telephone, via email or via online form:

- From your application for accommodation and completion of the forms provided by Barrington Lettings or Spencer Munson Property Services (including but not limited to credit reference forms and tenancy agreements).
- From information you provide directly to Andrew or Helen Kaymer.

We collect the following information about you:

- Tenant name, e-mail address, telephone number, Date of Birth, address (including any previous addresses), marital status, National Insurance Number, nationality, next of kin, name of university or college where you are studying (if applicable), the name of friends that you are staying with (if applicable);
- Guarantor name, e-mail address, telephone number, Date of Birth, address (including any previous addresses), marital status, National Insurance Number, nationality, next of kin (if applicable);
- Property address; term, rent, deposit, utility and service responsibilities;
- The employment status of tenants and/or guarantors, address, contact details (including email, phone and fax numbers) of the employer/accountant, payroll numbers, length of employment, salary information (including any regular overtime or commission), and any other income received;
- Bank account details of the tenant, including account number and sort code, and any hire purchase/loan agreements/credit cards or store cards that you have; and
- Any welfare benefits that you may be eligible for, or are currently on.

#### Why we need this information about you and how it will be used

We need your information and will use your information:

- to undertake and perform our obligations and duties to you in accordance with the terms of our contract with you;
- to enable us to supply you with the services and information which you have requested;
- to help you to manage your tenancy;

- to carry out due diligence on any prospective tenant, including whether there is any money judgements against them, or any history of bankruptcy or insolvency;
- to analyse the information we collect so that we can administer, support and improve and develop our business and the services we offer;
- to contact you in order to send you details of any changes to our or supplies which may affect you; and
- for all other purposes consistent with the proper performance of our operations and business.

## **Sharing of Your Information**

The information you provide to us will be treated by us as confidential and will be processed only by us or a third party, acting on our behalf. We may disclose your information to other third parties who act for us for the purposes set out in this notice or for purposes approved by you, including the following:

- To our managing agents Barrington Lettings or Spencer Munson Property Services and their authorised contractors;
- To other contractors authorised by Linnel 2 Property Services to provide maintenance or refurbishment for the property that you are renting;
- If we enter into a joint venture with or merged with a business entity, your information may be disclosed to our new business partners or owners;
- To carry out due diligence on you as a prospective tenant/ guarantor, including but not limited to the
  carrying out of affordability checks, due diligence checks and the obtaining of references from relevant
  parties, whose data you have provided;
- If you request so, your information shall be disclosed in order to determine if there are any money judgements against you, as the prospective tenant/guarantor, or to determine if they have a history of bankruptcy or insolvency;
- If you are unable to make payments under your tenancy, your information may be disclosed to any relevant party assisting in the recovery of this debt or the tracing of you as a tenant; and
- In the creation, renewal or termination of the tenancy, your information will be disclosed to the relevant local authority, tenancy deposit scheme administrator, service/utility provider, freeholder, factor, facilities manager or any other relevant person or organisation in connection with this.

Unless required to do so by law, we will not otherwise share, sell or distribute any of the information you provide to us without your consent.

#### Transfers outside the UK and Europe

We may transfer your information outside the UK and/or EEA]:

Information may be transferred outside the UK and/or EEA insofar as data stored on the cloud on Microsoft servers may be held outside the UK and/or EEA. Where information is transferred outside the UK or EEA, we ensure that there are adequate safeguards in place to protect your information in accordance with this notice, because we use Microsoft products for which the following privacy notice is applicable: Microsoft adheres to applicable data protection laws in the European Economic Area (<a href="https://privacy.microsoft.com/en-gb/privacystatement">https://privacy.microsoft.com/en-gb/privacystatement</a>)

When you give us information we take steps to make sure that your personal information is kept secure and safe. When stored electronically the computers and/or software are password-protected. When physical records are stored in our office the building is alarmed when we are not present.

### How long we will keep your information

We review our data retention periods regularly and will only hold your personal data for as long as is necessary for the relevant activity, or as required by law (we may be legally required to hold some types of information), or as set out in any relevant contract we have with you. We would hold your personal data until five years after the January 31 following the relevant tax year when you cease to be a tenant ie if you

cease to be a tenant in March 2020 we would hold your records until January 31, 2026, while if you cease to be a tenant in May 2020 we would hold your records until January 31, 2027.

## **Your Rights**

You have the right at any time to:

- ask for a copy of the information about you held by us in our records;
- require us to correct any inaccuracies in your information;
- make a request to us to delete what personal data of yours we hold; and
- object to receiving any marketing communications from us.
